Subject: Grant of ADDITIONAL Post Diploma DNB Seats for 2025 Admission Session

Sir/Madam,

This is with reference to NBEMS letters no. **NBEMS/EDO/2025/182** dated **18-03-2025** & **NBEMS/EDO/2025/236** dated **16-04-2025**

2. Through the aforementioned letters, the **State of Uttar Pradesh** was requested to provide the distribution of Post Diploma DNB seats available in certain Government hospitals of Uttar Pradesh for the 2025 admission session in order to determine the following:

- No. of seats to be retained for in-service doctors in the state (maximum upto 50% seats).
- No. of seats to be contributed for central pool (All India quota) counseling.

3. In response to the above letters, the State of Uttar Pradesh has provided the distribution of Post Diploma DNB seats to NBEMS vide emails dated 24-03-2025 & 21-04-2025.

4. Meanwhile, following **NEW** Post Diploma DNB seats have been granted & added to the pool of government seats in **Uttar Pradesh** (in addition to the seats with reference to the above letters).

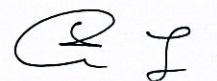
6. All instructions & guidelines mentioned in the NBEMS letter dated 18-03-2025 will remain applicable to these additional seats also.
